EASEMENT

THIS INDENTURE made and entered into this 9th day of May, 1941, by and between The Island Realty Company, a corporation, party of the first part and the City of Grand Island, party of the second part.

WITNESSETH: That the said party of the first part, in consideration of Seventy-five dollars (\$75.00) and other valuable consideration to it in hand paid by the said party of the second part, receipt whereof is hereby acknowledged, does hereby give and grant to the said party of the second part, the right to use for the passage of a water main in and under the land of the said party of the first part, as surveyed and platted in the accompanying plat hereto attached and made a part hereof, more particularly described as follows:

Commencing at a point where the West line of the County road running North and South through the Southwest Quarter (SW2) and the Southerly part of the Northwest Quarter (NW2) of Section Twenty-one (21), Township Eleven (11), Range Nine (9), intersects with the Southerly line of Anna Street in the City of Grand Island, Nebraska, running thence Southwesterly along the Southerly line of said Anna Street about 248 feet to the Westerly line of Logan Street, thence Southerly parallel with the Westerly line at Logan Street about 521 feet to a point where said line intersects the West line of said County road thence North along the West line of the said County road to the place of beginning.
