



SURVEY FOR FRED B. WINTER AND LEROY E. RAY

DESCRIPTION

BEGINNING AT A POINT ON THE SOUTHERLY LINE OF ANNA STREET EIGHT HUNDRED FIFTY NINE (859) FEET SOUTHWESTERLY FROM A POINT WHERE THE SOUTHERLY LINE OF ANNA STREET INTERSECTS THE EAST LINE OF THE SOUTHEAST QUARTER OF THE NORTHWEST QUARTER OF SECTION TWENTY ONE (21) IN TOWNSHIP ELEVEN (11), NORTH, RANGE NINE (9) WEST OF THE SIXTH P.M., THENCE TURNING A RIGHT ANGLE AND RUNNING IN A SOUTHWESTERLY DIRECTION PARALLEL WITH THE EASTERLY LINE OF JACKSON STREET, IF EXTENDED, FOR A DISTANCE OF THREE HUNDRED (300) FEET, THENCE RUNNING RIGHT NINETY (90) DEGREES IN A SOUTHWESTERLY DIRECTION, FOR A DISTANCE OF FOUR HUNDRED THIRTY (430) FEET, THENCE RUNNING LEFT NINETY (90) DEGREES, ALONG THE EASTERLY EXTENDED LINE OF HARRISON STREET, FOR A DISTANCE OF THREE HUNDRED SIX AND ONE TENTH (306.1) FEET; THENCE RUNNING IN A SOUTHWESTERLY DIRECTION PARALLEL WITH THE RIGHT OF WAY OF THE CHICAGO, BURLINGTON AND QUINCY RAILROAD FOR A DISTANCE OF TWO HUNDRED TWENTY ONE AND TWO TENTHS (221.2) FEET TO POINT TWENTY SIX (26) NORTHERLY FROM SAID RIGHT-OF-WAY, THENCE WEST FOR A DISTANCE OF ONE HUNDRED EIGHTY TWO AND FOUR TENTHS (182.4) FEET, TO THE EAST LINE OF THE COUNTY ROAD AND TWENTY SIX (26) FEET NORTH OF THE EAST AND WEST CENTERLINE OF SAID SECTION TWENTY ONE (21); THENCE RUNNING NORTH ON THE EAST LINE OF THE COUNTY ROAD TO THE SOUTHERLY LINE OF ANNA STREET; THENCE IN A NORTHEASTERLY DIRECTION ON THE SOUTHERLY LINE OF ANNA STREET TO THE PLACE OF BEGINNING.
