

TO THE NORTHEAST CORNER OF LOT SEVENTEEN (17), BLOCK ONE (1), STEWART PLACE SUBDIVISION; THENCE SOUTHERLY ALONG THE EAST LINE OF SAID LOT SEVENTEEN (17), BLOCK ONE (1), A DISTANCE OF ONE HUNDRED EIGHTY-THREE (183.0) FEET, TO THE SOUTHEAST CORNER OF SAID LOT SEVENTEEN (17), BLOCK ONE (1); THENCE WESTERLY ALONG THE SOUTH LINE OF SAID LOT SEVENTEEN (17), BLOCK ONE (1), A DISTANCE OF ONE HUNDRED SIXTY-NINE AND THIRTY-THREE HUNDREDTHS (169.33) FEET, TO THE EAST RIGHT-OF-WAY LINE OF THE UNION PACIFIC RAILROAD, ALSO BEING THE SOUTHWEST CORNER OF SAID LOT SEVENTEEN (17), BLOCK ONE (1); THENCE NORTHERLY ALONG SAID EAST RIGHT-OF-WAY LINE OF THE U. P. R. R., ALSO BEING THE WEST LINE OF STEWART PLACE SUBDIVISION, A DISTANCE OF NINE HUNDRED NINETY-ONE (991.0) FEET, TO THE NORTH LINE OF SAID SECTION TWENTY-NINE (29); THENCE EASTERLY ALONG SAID NORTH LINE OF SECTION TWENTY-NINE (29), A DISTANCE OF ONE HUNDRED SEVENTEEN AND NINETY-SEVEN HUNDREDTHS (117.97) FEET; THENCE SOUTHERLY PARALLEL TO SAID EAST LINE OF THE NW $\frac{1}{4}$ NE $\frac{1}{4}$, A DISTANCE OF THIRTY THREE (33.0) FEET; THENCE EASTERLY PARALLEL TO THE NORTH LINE OF SAID SECTION TWENTY-NINE (29), A DISTANCE OF ONE THOUSAND FIFTY-THREE (1,153.0) FEET TO THE PLACE OF BEGINNING, SAID TRACT CONTAINING 24.942 ACRES, MORE OR LESS.

WHEREAS, the above described real estate contiguous to and adjacent to the Village of Parkview, Hall County, Nebraska has been by the act, authority, and acquiescence of the owners thereof, surveyed, defined, and described.
