, herein called the grantor whether one or more,

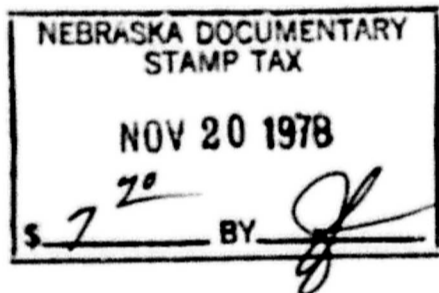
in consideration of SEVEN THOUSAND AND NO/100 DOLLARS

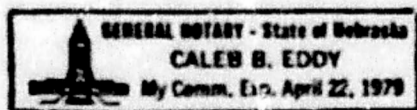
