 in hand paid, do hereby SELL and CONVEY unto Bank of Doniphan, Doniphan, Nebraska  
 of Hall County, State of Nebraska the following described premises situated  
 in Hall County, and State of Nebraska, to-wit:

 Comprising a part of the West Half of the Southwest  
 Quarter (W $\frac{1}{2}$ SW $\frac{1}{4}$ ) of Section Two (2), Township Nine (9)

 County, Nebraska.

The intention being to convey hereby an absolute title in fee simple, including all the rights of homestead and dower.
