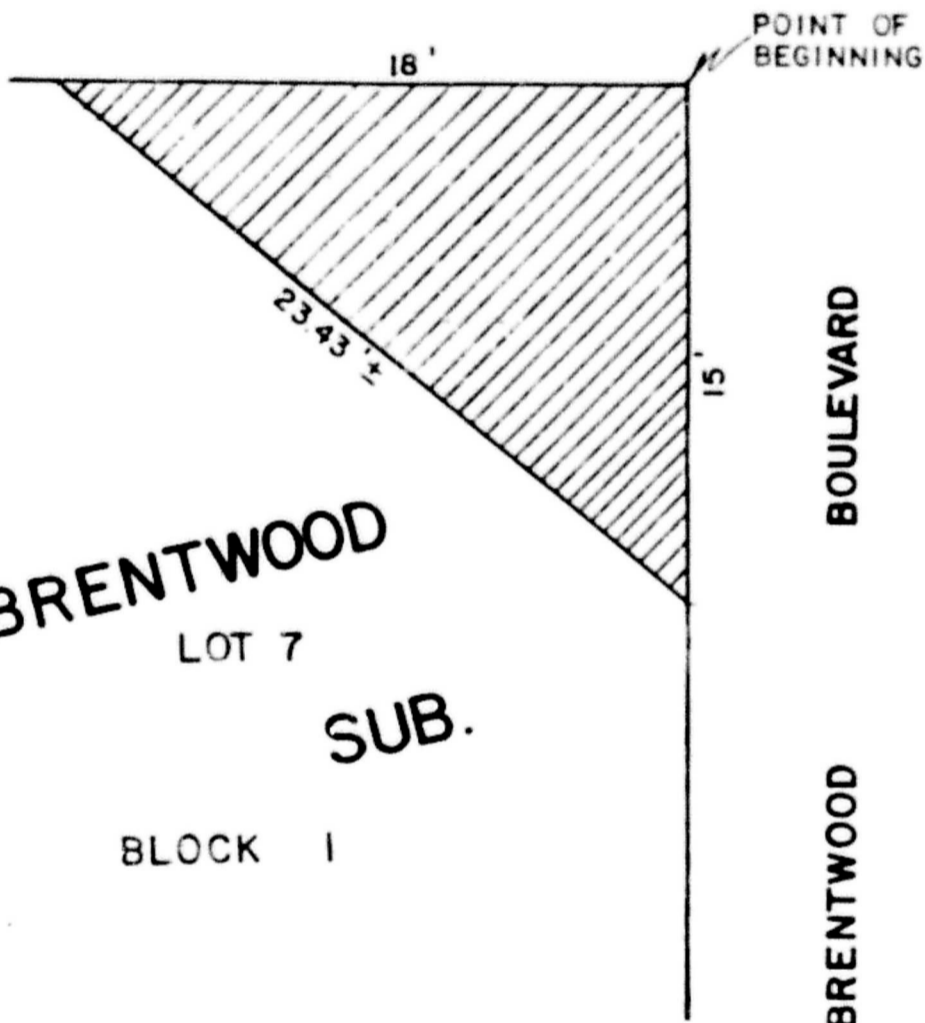

STOLLEY PARK ROAD




 RIGHT OF WAY ACQUIRED FROM
