Lot Thirteen (13), in Block One (1), in Continental Gardens, an Addition to the City of Grand Island, Hall County, Nebraska.

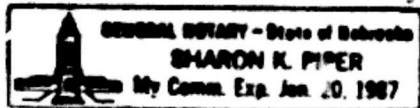

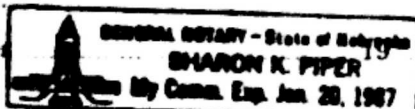
