

AN ORDINANCE TO EXTEND THE BOUNDARIES AND INCLUDE WITHIN THE CORPORATE LIMITS OF, AND TO ANNEX TO, THE VILLAGE OF ALDA, NEBRASKA, CERTAIN CONTIGUOUS LAND DESCRIBED AS LOTS EIGHT (8), NINE (9), TEN (10), ELEVEN (11) AND TWELVE (12), IN THE COUNTY SUBDIVISION OF THE NORTHWEST QUARTER (NW $\frac{1}{4}$) AND THE WEST ONE-HALF (W $\frac{1}{2}$) OF THE NORTHEAST QUARTER (NE $\frac{1}{4}$) OF SECTION FIVE (5), TOWNSHIP TEN (10) NORTH, RANGE TEN (10) WEST OF THE 6th P.M., HALL COUNTY, NEBRASKA.

BE IT ORDAINED BY THE CHAIRMAN AND BOARD OF TRUSTEES OF THE VILLAGE OF ALDA, NEBRASKA:

SECTION 1. It is hereby found and determined by said Chairman and Board of Trustees that:

(a) The tract described as Lots Eight (8), Nine (9), Ten (10), Eleven (11) and Twelve (12), in the County Subdivision of the Northwest Quarter (NW $\frac{1}{4}$) and the West One-half (W $\frac{1}{2}$) of the Northeast Quarter (NE $\frac{1}{4}$) of Section Five (5), Township Ten (10) North, Range Ten (10) West of the 6th P.M., Hall County, Nebraska; is urban and suburban in character and contiguous to the corporate limits of said Village;

(b) There is a unity of interest in the use of said tract with the use of lots and tracts in said Village and the community convenience and welfare and the interest of said Village will be enhanced through incorporating said tract within the limits of said Village.

SECTION 2. That the boundaries of the Village of Alda, Nebraska, be, and hereby are, extended to include within the corporate limits of said Village the contiguous and adjacent land described as Lots Eight (8), Nine (9), Ten (10), Eleven (11) and Twelve (12), in the County Subdivision of the Northwest Quarter (NW $\frac{1}{4}$) and the West One-half (W $\frac{1}{2}$) of the Northeast Quarter (NE $\frac{1}{4}$) of Section Five (5), Township Ten (10) North, Range Ten (10) West of the 6th P.M., Hall County, Nebraska.

SECTION 3. Said land above described in Section 2 of this Ordinance is hereby annexed to the Village of Alda, Hall County, Nebraska.

SECTION 4. This Ordinance is enacted under authority of and in reliance upon Nebraska Revised Statute Section 17-405.01.

SECTION 5. This Ordinance shall be in force and take effect from and after its passage, approval, and posting or publication, as by law provided.
