Affiant further states that Thermoglas of Omaha, Nebraska, does hereby claim a lien on said building for the full amount



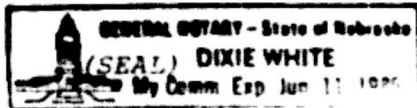
