



DESCRIPTIONS

Six (6) tracts of land comprising parts of Block 10 (Waggener Park) and vacated Vine Street adjacent thereto; all being in Morris Fifth Addition to the City of Grand Island, Nebraska and more particularly described as follows:

1. Beginning at the northeasterly corner of Lot 1, Block 9, Morris Fifth Addition; thence running northeasterly along the southerly line of 20th Street a distance of One Hundred Thirty (130.0) feet to a point on the westerly line of Plum Street; thence southeasterly along the westerly line of Plum Street a distance of One Hundred Thirty Seven and Four Tenth (137.4) feet to a point on the northerly line of an alley; thence running southwesterly along the northerly line of said alley a distance of One Hundred Sixty Eight (168.0) feet to the southeasterly corner of said Lot 1, Block 9; thence running northwesterly along the easterly line of said Lot 1, Block 9 a distance of One Hundred Thirty Two (132.0) feet to the point of beginning.

2. Beginning at the northeasterly corner of Lot 12, Block 9, Morris Fifth Addition; thence running northeasterly along the southerly line of an alley a distance of One Hundred Seventy (170.0) feet to a point on the westerly line of Plum Street; thence southeasterly along the westerly line of Plum Street a distance of One Hundred Thirty Three (133.0) feet to a point on the northerly line of 19th Street; thence running southwesterly along the northerly line of 19th Street a distance of One Hundred Eighty Six (186.0) feet to the southeasterly corner of said Lot 12, Block 9; thence running northwesterly along the easterly line of said Lot 12, Block 9 a distance of One Hundred Thirty Two (132.0) feet to the point of beginning.

3. Beginning at the northeasterly corner of Lot 1, Block 8, Morris Fifth Addition; thence running northeasterly along the south line of 19th Street a distance of One Hundred Ninety Five (195.0) feet to a point on the westerly line of Plum Street; thence running southeasterly along the westerly line of Plum Street a distance of One Hundred Thirty and Two Tenths (130.2) feet to a point on the northerly line of an alley; thence running southwesterly along the northerly line of said alley a distance of Two Hundred Two and One Tenth (202.1) feet to the southeasterly corner of said Lot 1, Block 8; thence northwesterly along the easterly line of said Lot 1, Block 8 a distance of One Hundred Thirty (130.0) feet to the point of beginning.

4. Beginning at a point on the northerly line of 18th Street, said point being Seventy (70.0) feet northeasterly from the southeasterly corner of Lot 12, Block 8, Morris Fifth Addition; thence northwesterly and parallel to the easterly line of said Lot 12 a distance of One Hundred Thirty (130.0) feet to a point on the southerly line of an alley; thence northwesterly along the southerly line of said alley a distance of One Hundred Thirty Two and Nine Tenths (132.9) feet to a point on the westerly line of Plum Street; thence southeasterly along the westerly line of Plum Street a distance of One Hundred Thirty and Two Tenths (130.2) feet to a point on the northerly line of 18th Street; thence southwesterly along the northerly line of 18th Street a distance of One Hundred Forty (140.0) feet to the point of beginning.

5. Beginning at a point on the southerly line of 18th street, said point being One Hundred Forty (140.0) feet northeasterly from the northeasterly corner of Lot 1, Block 7, Morris Fifth Addition; thence northeasterly along the southerly line of 18th Street a distance of Seventy (70.0) feet to a point on the westerly line of Plum Street; thence southeasterly along the westerly line of Plum Street a distance of One Hundred Thirty (130.0) feet to a point on the northerly line of an alley; thence southwesterly along the northerly line of said alley a distance of Seventy (70.0) feet to a point that is One Hundred Forty (140.0) feet northeasterly from the southeasterly corner of said Lot 1, Block 7; thence northwesterly a distance of One Hundred Thirty (130.0) feet to the point of beginning.

6. Beginning at a point on the northerly line of 17th street, said point being Seventy (70.0) feet northeasterly from the southeasterly corner of Lot 12, Block 7, Morris Fifth Addition; thence northwesterly and parallel to the easterly line of said Lot 12 a distance of One Hundred Thirty (130.0) feet to a point on the southerly line of an alley; thence northwesterly along the southerly line of said alley a distance of One Hundred Forty (140.0) feet to a point on the westerly line of Plum Street; thence southeasterly along the westerly line of Plum Street a distance of One Hundred Thirty (130.0) feet to a point on the northerly line of 17th Street; thence southwesterly along the northerly line of 17th Street a distance of One Hundred Forty (140.0) feet to the point of beginning.

DEDICATION
