

## DESCRIPTION

Plat of a tract of land in the NI/2 of the NE 1/4 of Section Eleven (11), Township Eleven (II) North, Range Ten (IO) West of the 6th P.M., Hall County, Nebraska and more particularly described as follows:

Beginning at a point on the east line of said NE 1/4; said point being Two Hundred Fifty (250.0) feet south of the northeast corner of said NE 1/4; said point also being the southeast corner of SUNSET SUBDIVISION; thence running westerly along and upon the south line of SUNSET SUBDIVISION which is parallel to the north line of said NEI/4 a distance of One Thousand Three Hundred Twenty (1320.0) feet; thence running southerly and parallel to the east line of said NE 1/4 a distance Three Hundred (300.0) feet; thence running easterly and parallel to the north line of said NE 1/4 a distance of One Thousand Three Hundred Twenty (1320.0) feet to a point on the east line of said NE 1/4; thence running northerly along and upon the east line of said NE 1/4 a distance of Three Hundred (300.0) feet to the point of beginning and containing 9.091 acres more or less.
