

Quarter (NW $\frac{1}{4}$ ) of the Southwest Quarter (SW $\frac{1}{4}$ ) of said Section Twenty-One (21), said point also being on the North line of Kay-See Subdivision; thence running Westerly along and upon the North line of Kay-See Subdivision, to the Northwest corner of said Kay-See Subdivision; thence running Southerly along and upon the West line of said Kay-See Subdivision, said line also being the West line of said Section Twenty-One (21), a distance of Seven Hundred Seventy-Eight and Two Tenths (778.2) feet; thence running Easterly along and upon the South line of said Kay-See Subdivision, a distance of Four Hundred Twenty-Two and Two Tenths (422.2) feet; thence running Southerly along and upon the West line of said Kay-See Subdivision a distance of Five Hundred Thirty-Eight (538.0) feet, to a point on the South line of said Section Twenty-One (21); thence running Easterly along and upon the South line of said Section Twenty-One (21), to a point perpendicular to the West line of Park Drive in ParkView Subdivision as platted and recorded; thence running Southerly along and upon the West line of said Park Drive as platted and recorded, to a point; thence running Southwesterly along and upon the Northwesterly line of said Park Drive as platted and recorded, a distance of Sixty-Three and Two Tenths (63.2) feet; thence running Southerly along and upon the West line of Park-View Subdivision, also being the West line of said Park Drive, a distance of Nine Hundred Twelve and Three Tenths (912.3) feet; thence running Westerly along and upon the North line of Park-View Subdivision, also being the North line of said Park Drive, a distance of One Thousand Seven Hundred Ninety-Eight and Fifteen Hundredths (1,798.15) feet, to a point Thirty-Three (33.0) feet East of the West line of East Half (E $\frac{1}{2}$ ) of the Northeast Quarter (NE $\frac{1}{4}$ ) of Section Twenty-Nine (29), Township Eleven (11) North, Range Nine (9) West of the 6th P.M. in Hall County, Nebraska; thence running Southerly along and upon the West line of said Park-View Subdivision, a distance of One Thousand Six Hundred Thirty-One (1,631.0) feet to the Southwest corner of said Park-View Subdivision; thence running Easterly along and upon the South line of Park-View Subdivision, a distance of Two Thousand Six Hundred Twenty-Six and Two Tenths (2,626.2) feet, to the Southeast corner of said Park-View Subdivision; thence running Northerly along and upon the East Line of said Park-View Subdivision, to the Southwest corner of Lot Eight (8), Block Three (3), Country Club Subdivision; thence running Easterly along and upon the South line of Country Club Subdivision, a distance of Two Hundred Forty-Seven and Five Tenths (247.5) feet; thence running Northerly along and upon the East line of Riverview Drive in said Country Club Subdivision, a distance of Thirty-Three (33.0) feet; thence running Easterly along and upon the South line of said Country Club Subdivision, a distance of Three Hundred Seventy-Five (375.0) feet; thence
