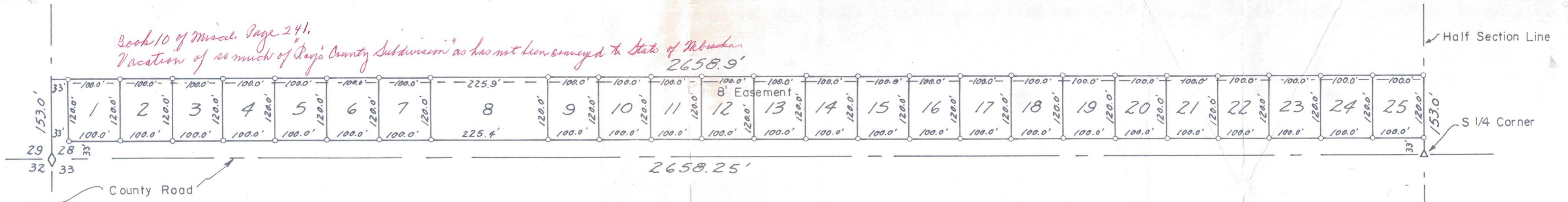

Vacation of so much of Ray's County Subdivision as has not been conveyed to State of Nebraska.



DESCRIPTION

Plat of a tract of land in the Southwest Quarter (SW 1/4) of Section Twenty Eight (28), Township Eleven (11) North, Range Nine (9) West of the 6th P.M., Hall County, Nebraska and more particularly described as follows:

Beginning at the southwest corner of said Section 28; thence running easterly along and upon the south line of said SW 1/4 a distance of Two Thousand Six Hundred Fifty Eight and Twenty Five Hundredths (2658.25) feet to the South Quarter corner of Section 28; thence running northerly along the half section line a distance of One Hundred Fifty Three (153.0) feet; thence running westerly and parallel to the south line of the SW 1/4 a distance of Two Thousand Six Hundred Fifty Eight and Nine Tenths (2658.9) feet to a point on the west line of the SW 1/4; thence running southerly along and upon the west line the SW 1/4 a distance of One Hundred Fifty Three (153.0) feet to the point of beginning and containing 9.338 acres more or less.

DEDICATION

KNOW ALL MEN BY THESE PRESENTS, That I, LEROY E. RAY, in his own right, being the owner of the land described hereon, have caused same to be surveyed, subdivided, platted and designated as "RAY'S COUNTY SUBDIVISION" as shown on the accompanying plat and do hereby dedicate the roads as thereon shown to the public for their use forever and the easements as thereon shown for the location, construction and maintenance of public utilities forever, and that the forgoing subdivision, as more particularly described in the description hereon as appears on this plat, is made with the free consent and in accordance with the desire of the undersigned owner and proprietor.

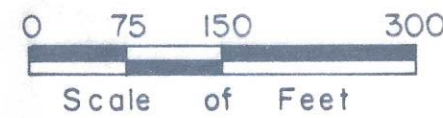
