

AN UNDIVIDED $\frac{1}{4}$ INTEREST IN THE FOLLOWING:
Lots numbered Five (5), Six (6) and Seven (7), in Block numbered Sixteen (16), in the Original Town new Village of Dannebrog, Howard County, Nebraska, according to the recorded plat thereof now on file in the office of the County Clerk, except a parcel of land particularly described as follows: "Commencing at a point sixty-four (64) feet West of the Southeast corner of Lot Seven (7), of Block Sixteen (16), of the Original Town of Dannebrog, Nebraska, thence West parallel with the street or alley Seventy-two (72) feet, thence North two (2) degrees East two hundred fifteen (215) feet, thence along the creek bank East fifty-four (54) feet six (6) inches, thence South seven (7) degrees West two hundred fifteen (215) feet to the place of beginning"; in Howard County, Nebraska.

AN UNDIVIDED $\frac{1}{4}$ INTEREST IN THE FOLLOWING:
Also a tract of land described as follows: Beginning at the Southeast corner of Lot Seven (7) in Block Sixteen (16), in the Original Town of Dannebrog, Howard County, Nebraska, running South in line with and as a continuation of the East line of said Lot Five (5), twenty-five (25) feet; thence West parallel with the South line of Lots Seven (7), six (6) and Five (5) in said Block, to the intersection of Pioneer Avenue; thence Northwest along the East line of said Lot Five (5); thence along the South side of Lot Five (5), Six (6) and Seven (7), in said Block Sixteen (16), to the place of beginning, said tract being a strip of land twenty-five (25) feet wide, in Fifth Street and contiguous to, and immediately South of said Lots Seven (7), Six (6) and Five (5), in said Block Sixteen (16); in Howard County, Nebraska.

AN UNDIVIDED $\frac{1}{4}$ INTEREST IN THE FOLLOWING:
A strip of ground sixteen (16) feet wide, running along the North side of Tax Lot Number Thirteen (13), in Section Two (2), Township Thirteen (13) North, of Range Eleven (11) West, from the east side of Fourth Street in the Village of Dannebrog, Howard County, Nebraska, 474 feet east, to the east line of said Tax Lot Number Thirteen (13);

which according to the terms and provisions of the Last Will and Testament of the deceased, descends and is assigned to Anna V. Larsen.

IT IS THEREFORE ORDERED, ADJUDGED, AND DECREED by the Court, that the Final Report be and is hereby in all things approved, confirmed, and allowed; that the entire estate, both real and personal, as described above, be and is hereby assigned to the said Anna V. Larsen, as the sole owner thereof and that she is discharged from her trust as Administratrix with Will Annexed and her bondsmen released.
