TESTE: In case any of the legatees or devisees hereinbefore named shall institute or prosecute any action to contest or set aside my last will and testament, the legacy or devise hereinbefore given to such person, persons or organization, shall be thereby forfeited and annulled and shall revert to the residuum of my estate and inure to the remainder residuary legatees in accordance with the percentages listed opposite their respective names; or in case any person or persons not named in this my last will and testament shall institute or prosecute any action to contest or set aside my last will and testament, such person or persons shall be disinherited and shall not be entitled to receive anything whatsoever from the proceeds of my estate.
