The Judgment herein against such estate and the heirs-at-law of such decedent for Nebraska State Inheritance Tax, be, and the same hereby is, decreed to be paid and satisfied.

IT IS, THEREFORE, CONSIDERED, ORDERED AND ADJUDGED that the administrator of the estate of Elfrieda Bartenbach, deceased, be, and hereby is authorized and directed to assign and deliver to such George W. Bartenbach, Helen Connell and Henrietta Baer, the following described certificates of stock, to-wit:
