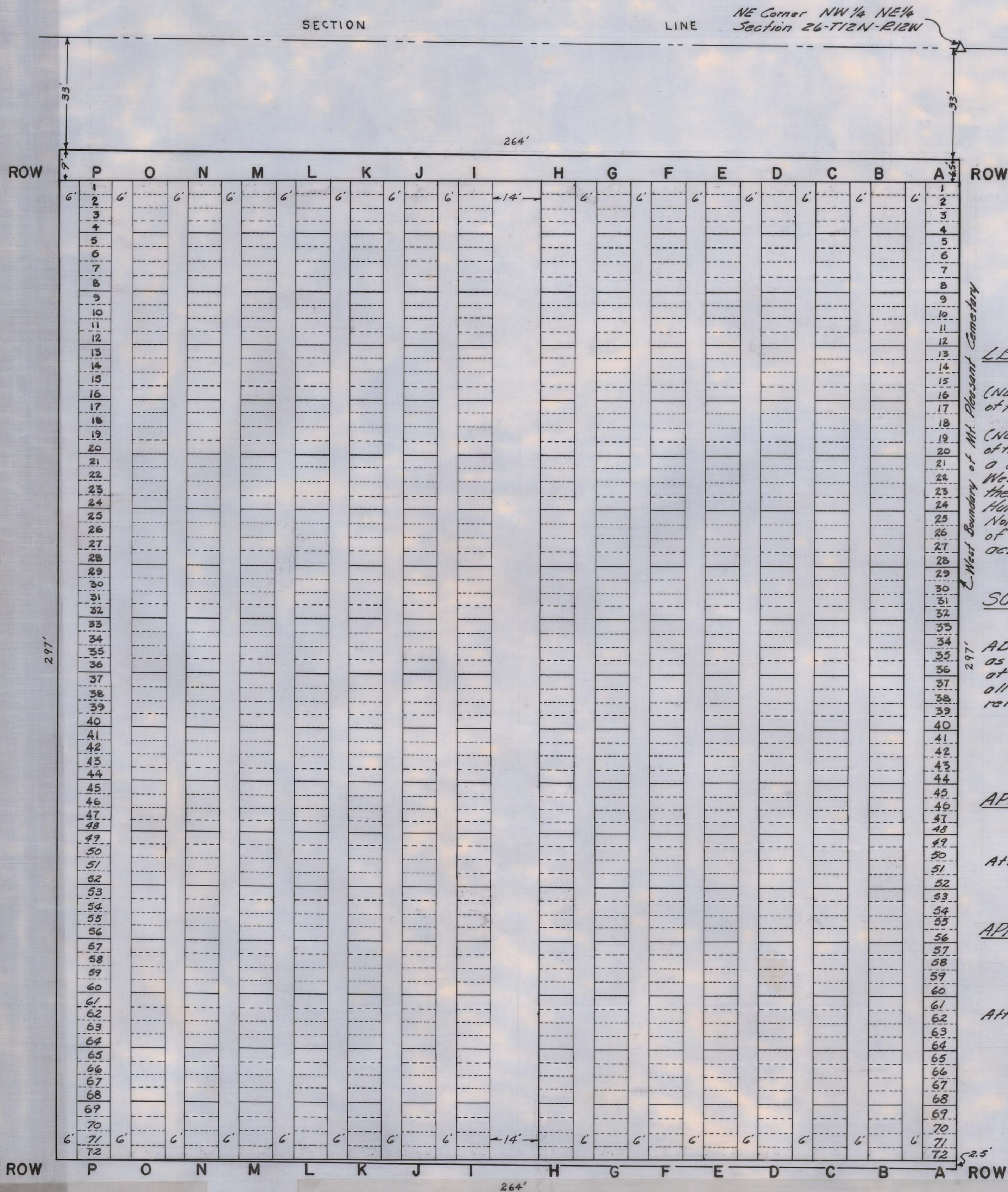

LEGAL DESCRIPTION

A tract of land located in the Northwest Quarter (NW 1/4) of the Northeast Quarter (NE 1/4) of Section Twenty Six (26), Township Twelve North (T12N), Range Twelve West (R12W) of the 6th P.M. in Hall County, Nebraska, more particularly described as follows:
Beginning at the Northeast (NE) corner of the West Half (W 1/2) of the Northeast Quarter (NE 1/4) of Section Twenty Six (26) Township Twelve North (T12N), Range Twelve West (R12W) of the 6th P.M.; thence Westerly along and upon the North line of said W 1/2 of the NE 1/4 a distance of Two Hundred Sixty Four (264) feet; thence Southerly parallel to the West boundary of Mt. Pleasant Cemetery, a distance of Three Hundred Thirty (330) feet; thence Easterly parallel to said North line of the W 1/2 of the NE 1/4 a distance of Two Hundred Sixty Four (264) feet, to the West boundary of Mt. Pleasant Cemetery; thence Northerly along and upon said West boundary of Mt. Pleasant Cemetery, a distance of Three Hundred Thirty (330) feet to the place of beginning, and containing 2.0 acres more or less.
