A strip of land off the East Side of the Senthunet Quarter (SM) of the Northeast Quarter (SM) and Let Two (2) on Island, in Section Thirteen (15), running from South to North through said premises with parallel sides 26; reds wide, containing about 23 2/3 agres, all in Section Thirteen (15), Tournship Bloven (11) North, Range Mins (9) West of the 6th P.M., Hall County, Northeasts

That under said last will and testament, all the property hereinbefore described did pass and descend by virtue of said will in fee simple title absolute to Lina Bassch after the payment of the just debts, including expenses of the last illness and burial of said Boward Bassch, deceased.

The Court further finds that due and legal notice has been given to all persons of the time and place of hearing on the final report herein by said executrix by publication for three successive weeks in the Grand Island Daily Independent, a legal newspaper, as by law required, and no one appearing to object to said report and the Court having examined the same, together with the nuchers and receipts thereto attached, finds that said report is true and correct in all things and should be allowed and approved as said executrix's final report; that there is no inheritance tax due the State of Rebraiks or the United States of America under the inheritance tax laws as said heirs and devisees have exemtions greater in amount than the total value of said estate and said estate should be settled and closed and said executrix and her official bonds—and discharged herein.

IT IS, THEREFORE, ORDERED, ADJUDGED AND DECREED BY THE COURT that all persons having claims against said estate not filed and allowed within the time fixed by the Court, if any such there be, are forever barred, excluded and entering from setting up or asserting any such claims against said estate.

IT IS FURTHER ORDERED, ADJUDGED AND DECREED BY THE COURT That the final report filed herein be and the same hereby is, in all things, allowed and approved as and for said executrix's final report and said estate is hereby settled and closed and said executrix and her official bondsman discharged from any further liability herein.

IT IS FURTHER ORDERED, ADJUDGED AND DECREED BY THE COURT that there is no inheritance tax due herein whatsoever and that said estate is not subject to any federal estate tax or state estate tax whatsoever.
