

2. The Northwest One-Fourth ($\frac{1}{4}$) of Section Six (6), Township Seven (7) North, Range Eight (8), in the County of Clay, State of Nebraska.
3. The North Thirty feet (30ft.) of Lot Twenty (20), and all to Lots Twenty-One (21), Twenty-Two (22), Twenty-Three (23), and Twenty-Four (24), in Cole's Subdivision of Block Twelve (12) of Cole's Addition to the City of Hastings, Adams County, Nebraska, and also now described as North Thirty feet (30ft.) of Lot Twenty (20); and South Ten feet (8.33ft.) and North Forty feet (4.33ft.) of Lot Twenty-One (21); and South Forty feet (3.33ft.) and North Ten feet (1.33ft.) of Lot Twenty-Two (22); and South Thirty feet (2.5ft.) and South Twenty feet (2.08ft.) of Lot Twenty-Three (23); and South Twenty feet (2.08ft.) and North Thirty feet (2.5ft.) of Lot Twenty-Four (24); all in Cole's Subdivision of Block Twelve (12) of Cole's Addition to the City of Hastings, Adams County, Nebraska; 4.4 acs or 1/24 acs Four (4), and the North One-Half of Lot Five (5), in Block Seven (7), of Cole's First Addition to the City of Hastings, Adams County, Nebraska;

6. That in addition to the fee simple title in and to an undivided one-half thereof, the widow, Anna Schardt, is entitled to and hereby is set off to her a life estate in and to all of the North Thirty feet (30ft.) of Lot Twenty-Four (24) of Cole's Subdivision of Block Twelve (12) of Cole's Addition to the City of Hastings, Adams County, Nebraska, and the tenements and hereditaments thereunto belonging, and to use, occupy and possess the same during her natural life.
7. That the owners in elevator stock and agricultural society, and the premises note given by A. C. Brandt, and other personal property which was in the name of Henry J. Schardt above, he, and the wife hereby is, assigned to Anna Schardt, the widow, and Randolph Edward Schardt, the son, and to each an undivided one-half thereof.
8. That the fee simple title in and to certain described real property, lands, tenements and hereditaments, and as appears in the deeds which were duly recorded, were purchased by said Henry J. Schardt and Anna Schardt as joint tenants, and not as tenants in common, with the right of survivorship, and upon the death of said Henry J. Schardt on the 7th day of April A. D. 1932, the whole fee simple titlevested in said Anna Schardt, the survivor, in and to said real property described as follows, to-wit:
1. The northeast One-Fourth ($\frac{1}{4}$) of Section Twenty-Four (24), Township Nine (9) North, Range Nine (9) west of the 6th P. M., in the County of Hall, State of Nebraska.
 2. The northwest One-Fourth ($\frac{1}{4}$) of Section Twenty (20), and the west Twenty acres (20) of the Northeast One-Fourth ($\frac{1}{4}$) of Section Twenty (20), all in Township Nine (9) North, Range Nine (9) west of the 6th P. M., in the County of Hamilton, State of Nebraska.
