

23. The Northeast One-Fourth (NE<sup>1</sup>/<sub>4</sub>) of Section Thirteen (13), Township Six (6) North, Range Eleven (11) east of the 6th P. M., in the County of Adams, State of Nebraska.

24. The South One-half (S<sup>1</sup>/<sub>2</sub>) of the Northeast One-Fourth (NE<sup>1</sup>/<sub>4</sub>), and the North One-Half (N<sup>1</sup>/<sub>2</sub>), of the Southeast One-Fourth (SE<sup>1</sup>/<sub>4</sub>) of Section Thirteen (13), Township Six (6) North, Range Nine (9) east of the 6th P. M., in the County of Adams, State of Nebraska.

25. Lots Nine (9) and Ten (10) of Block Eleven (11) of Saint Johns Addition to the City of Hastings, Adams County, Nebraska.

And the said fee simple title in and to the above and foregoing real property, lands, tenements and hereditaments, described in each of the numbered paragraphs 1 to 25 be, and the same hereby is, assigned to said Anna Eckhardt, the survivor.

8. That the whole title and ownership of the cash on hand in the sum of \$60540.00 and on deposit in the Banks of Hastings, Nebraska, in the accounts and name of Henry O. Eckhardt and Anna Eckhardt, either or survivor, be, and hereby is, assigned to said Anna Eckhardt, the survivor.

9. That the title and ownership of the five United States Savings bonds, Series "B", payable to Henry O. Eckhardt and Anna Eckhardt, and issue date, number and amount as follows: September 1943, C405154268 \$75; September 1943, C478235058 \$75; February 1944, C670187558 \$75; July 1944, 0769734344 \$75; November 1944, C211700214 \$75; be, and hereby are, assigned to said Anna Eckhardt, the survivor.

11. That the title and ownership of all personal property, and all real property in the names of Henry O. Eckhardt and Anna Eckhardt, either or survivor, be, and hereby is assigned, to the said Anna Eckhardt, the survivor.

12. That all inheritance taxes under the laws of the State of Nebraska upon all of said property of every kind and nature and the respective interests therein have been duly assessed in the total amount of \$3885.49 and have been paid as provided by the laws of the State of Nebraska.

13. That the United States Income Tax for the calendar year commencing January 1, 1952, and ending January 1, 1953, has been duly made as a joint return and filed, and the taxes therein shown to be due in the sum of \$8858.10 have been duly paid in full to the Director of Internal Revenue, Omaha, Nebraska, and United States Fiduciary Tax Return has been duly made and filed with the Director of Internal Revenue, Omaha, Nebraska, and the United States Estate Tax Return has been duly made and filed with said Director of Internal Revenue, Omaha, Nebraska, and all taxes therein shown to be due in the sum of \$10058.21 have been duly paid to him, and Anna Eckhardt has duly filed with said Director of Internal Revenue, Omaha, Nebraska, her Declaration of Estimated Income Tax for the calendar year commencing January 1, 1953, and ending January 1, 1954, and has paid thereon to him the sum of \$6000.00.

14. That the estate tax return to the State of Nebraska has been duly made and filed with the State Tax Commissioner of the State of Nebraska, Lincoln, Nebraska, on the forms provided by him, and showing no tax due the State of Nebraska.

15. That the joint administrators herein, having performed their duties as ordered by this court, and delivered possession of all of the remaining property to the parties entitled thereto, and all as found, adjudged and decreed by this court, be, and they hereby are, released and discharged, and their bond be, and hereby is released, satisfied and cancelled.
