IT IS THEREFORE, ORDERED, ADJUDGED AND DECREED BY THE COURT that the report and account of the executors herein be, and the same hereby is, in all things approved and allowed.

IT IS FURTHER ORDERED, ADJUDGED AND DECREED BY THE COURT that under the last will and testament of Emma L. Muhlbach, deceased, the following described real estate, to-wit:

IT IS FURTHER ORDERED, ADJUDGED AND DECREED BY THE COURT that the executors herein retain in their hands the promissory note and mortgage of Fred Sternberg and Alma Sternberg and the additional sum of \$1,000.00 in cash pending a final determination of Federal estate taxes and for payment of personal property taxes assessed against this said estate, and that the executors be, and they hereby are, ordered to distribute the balance of the funds in their hands in accordance with the terms of the last will and testament of the deceased as follows:
