time of her death and this court has jurisdiction; that che left a last Will and Testament, which has heretofore been admitted to probate by this court, and which probate has never been set aside or appealed from.

The Court further finds that the said Anna Davis was the suner at the time of her death of the following described real estate, to-wit:

Seutheast Cuarter of the Southeast Cuarter (SE; SE;), South Half of the Northeast Cuarter of the Southeast Cuarter (S; NE; SE;), Northwest Cuarter of the Southeast Cuarter (NE; NE; SE;), East Malf of the Northwest Cuarter (NE; NE; SE;), East Malf of the Northwest Cuarter of the Southeast Cuarter (S; NE; SE;), the Morthwest Cuarter of the Northeast Cuarter (NE; NE;), and East Half of the Southwest Cuarter of the Horthwest Cuarter (S; SE; NE;), all of Section Thelia (12), Township Eleven (11), North, of Range Ien (10), Hest of the 6th P.N., in Hall County, Nebraska, centaining approximately 150 acree more or less,

and that the same was devised in said last Will and Testament.

IT IS, THEREFORE, ORDERED, ADJUDGED AND DECREED BY THE COURT that the real estate hereinbefore despribed and the same is hereby sent off unto Inex May Maurer and Intherine Ann Maurer Hilker, in adcordance with the provisions of baid last Fill and Testament.

And now the Executriz having paid the items hereinbefore set forth, IT IS HEREST ORDERED, ADJUDGED AND DECREED BY THE COURT that the Executriz be and she is hereby discharged, her bond maded, and this setate finally closed.
