

LAST WILL AND TESTAMENT  
OF

I, Tena Beck, 418 West 13th Street, Grand Island, Hall County, Nebraska, being of sound mind and disposing memory, do hereby make, publish and declare this my Last Will and Testament.

I.

I appoint my sons, Wilbur H. Beck and Delbert G. Beck, of Grand Island, Nebraska, or the survivor of them, executors of this, my Last Will and Testament, and direct that no bond or security of any kind shall be required of them.

In case of the death, resignation, or inability of both sons to act hereunder, then I authorize and direct the court having jurisdiction of my estate to appoint an administrator with will annexed, and such person shall give bond, as required by law.

II.

I direct that all of my debts, funeral and testamentary expenses shall be paid as soon after my death as can be conveniently done.

III.

All the rest, residue and remainder of my property, real, personal and mixed, of which I shall die seized and possessed, and to which I am entitled at the time of my death, I give, devise and bequeath to my said sons, Wilbur H. Beck and Delbert G. Beck, equally, share and share alike, to have and to hold forever.

IV.

In the event that the beneficiaries named herein, or either of them, shall die prior to my death, leaving lawful issue him or her surviving, then I give, devise and bequeath to the surviving lawful issue of such deceased beneficiary or beneficiaries, the part and portion of my estate which the deceased beneficiary or beneficiaries would have taken and received hereunder, equally, share and share alike.

In the event that either of the beneficiaries named herein shall die prior to my death, leaving no lawful issue him surviving, then the legacy and devise given to such deceased beneficiary shall lapse, and the surviving beneficiary, or the living issue of the deceased beneficiary, shall take all of the residue of my estate.

In the event that both of the beneficiaries named herein shall die prior to my death, leaving no lawful issue them surviving, then I give, devise and bequeath the residue of my estate to my heirs at law in the share and portion as they would take under the laws of descent of the State of Nebraska, as now in force and effect.

V.

I hereby revoke any and all former wills by me made.
