

know all men by these presents, That, whereas the Citizens National Bank of Grand Island, Nebraska a Corporation, and a National Bank, duly organized and existing under the laws of the United States regulating National Banks, suspended payment on or about the fourth day of December A.D. 1893, and thereupon surrendered all its assets and property into the custody of the Comptroller of Currency of the United States and Edgar M. Westervelt was thereupon duly appointed and Commissioned as Receiver thereof, and whereas said Edgar M. Westervelt with the advice and consent of the Committee of the Creditors of said Bank negotiated a sale of the premises hereinafter described to the County of Hall in the State of Nebraska in consideration of surrender of Receiver's Certificate No 49 for the sum of Nine Thousand One hundred six & $\frac{1}{2}$ Dollars, and the payment of all taxes due on all of Lot 6 of the Co Sub. of Tr² SW⁴ Sec 15 - 11-9. And whereas said proposed sale has been submitted to and approved by the Comptroller of Currency of the United States, and the said Edgar M. Westervelt has been by the District Court of Hall Co duly authorized and empowered to sell said premises and to make, execute, acknowledge and deliver to said The County of Hall a deed for said premises Conveying and Confirming to said The County of Hall all the right, title and interest of said Bank in said premises for the consideration aforesaid.

Tow therefore I, Edgar M. Westervelt, Receiver as aforesaid, in consideration of the premises and said Certificate for the sum of Nine Thousand One hundred six & $\frac{1}{2}$ Dollars, the receipt whereof is hereby acknowledged and Confirmed, do hereby grant bargain sell and convey unto The County of Hall in the State of Nebraska, all the following described Real Estate situated in the County of Hall and State of Nebraska, to-wit:

Lot number One (1) of Westervelt's Subdivision of Lot number Six (6) of County Subdivision of the West half ($\frac{1}{2}$) of the South west quarter (SW $\frac{1}{4}$) of Section Fifteen (15) Township No. Eleven (11) Range No. Nine (9) rest of the 6th P.M. And all of fractional Block Ninety (90) of the original Town of Grand Island, in the North west quarter of Section Fifteen (15) Township No. Eleven (11) Range Nine (9) west of the 6th P.M. (Reserving to myself all the Buildings on said land) together with all and singular the tenements, hereditaments and appurtenances therunto belonging and all the estate, right, or title whatsoever of the said Bank, or of the said Edgar M. Westervelt as Receiver thereof, in and to said premises. To have and to hold the same unto the said The County of Hall, heirs and assigns forever, subject nevertheless to all taxes levied or assessed against said premises, and I do hereby commence with said The County of Hall, that I have good right and lawful authority to sell and convey said premises, and that I will hereafter make, execute, acknowledge and deliver any and all such other or further deeds or Conveyances as may be necessary or expedient to convey and transfer to said purchaser or assigns all right and title of said Bank or myself as receiver thereof, of, in and to said premises, thereby averring against the lawful claims of all persons whosoever claiming by through or under me and none others.
